

## LATTA SCHOOL BOARD

### Minutes

January 11, 2022

The Latta School Board of Trustees met for the regular monthly meeting on Tuesday, January 11, 2022 at 6:00 p.m. in the District Administrative Conference Room. In accordance with S.C. Code of Laws of 1976, as amended, Section 30-4-80(E). *The Dillon Herald* was notified of the time, date, place and agenda of this meeting. The agenda is also posted in the District Office and on the district website.

Trustees present were Kyle Berry, Ray George, Vanessa Harrison, Kwame Hennagan, Stuart Poston, Eleanor Powers and Jo Ann Williamson.

Chair Kyle Berry welcomed all present and George Liebenrood opened with prayer.

Jodie Branham recognized Sophia McLain Roberts for her achievement of excellence in being selected to attend the South Carolina Music Educators Association All-State Chorus Clinic at Winthrop University.

There being no corrections or additions to the November 2, 2021 and November 9, 2021 minutes and the current agenda, Eleanor Powers made a motion that they stand approved. Stuart Poston seconded the motion. Vote was unanimous.
