Minutes of Business Meeting of Board of Directors of The Latta Schools Educational Foundation, Inc. February 8, 2011

A business meeting of the Board of Directors of The Latta Schools Educational Foundation, Inc. was held at the Latta Early Childhood Center on February 8, 2010 at 6:00 p.m. Present were: Glenn Greene, III, Harold Kornblut, LaFon LeGette, Donna Taylor and John Kirby, being persons designated as the Directors in the Articles of Incorporation and /or participating as directors of the Board of Directors.

John Kirby, Chairman of the Board, approved the minutes of the December 2, 2010 meeting.

General discussion was held about the re-election of directors. Donna Taylor tendered resignation from the Board of Directors. Unanimous decision was made appointing Donna Taylor as an ex officio member with duties of recording secretary and financial reporter and re-electing for a three year term John Kirby as Board Chair, Glenn Greene, III as President, and Harold Kornblut as Secretary.

Donna Taylor presented a status report on the Latta Educational Foundation account. (Report attached becoming part of the minutes.) General discussion followed concerning the investment of restricted and non-restricted funds. Consensus was that Glenn Greene and Donna Taylor would bring back a proposal for consideration at the next meeting.

Glenn Greene gave an update on the major donor gift and will report back on the transferring of funds.

General discussion was held concerning the transfer of non-vital school property to the foundation. A motion was made by LaFon LeGette, seconded by Harold Kornblut, and voted unanimously for Glenn Greene to make a request to the Latta School Board for the transfer of non-vital school properties to the Latta Educational Foundation,

General discussion was then held concerning the addition of potential directors for the foundation,

LaFon LeGette presented a review of the by-laws and will report any recommended changes for consideration.

With no further business, the meeting was adjourned.
